



Privacy Statement

At Volume, we are committed to respecting and protecting your privacy. The purpose of this privacy statement is to help you understand how we use your information, when and why we collect it, and how we keep it secure.

When you use the Volume website you are agreeing to our Website Terms of Use [[link to website terms of use](#)] of which this privacy statement forms part. This means that any information you upload about yourself can be dealt with in line with this privacy statement.

Who are we?

We are Volume Limited, a company registered in England and Wales under registration number 03278281 with its registered office at Buckhurst Court, London Road, Wokingham, Berkshire, RG40 1PA, United Kingdom.

What information do we collect?

We collect and process information that you enter into our website, which we call our 'DIGITAL CONCIERGE' ® application, as well as correspondence you may have with us by phone, e-mail or otherwise. You are free to ask our website any question, but if you provide information of a personal or sensitive nature, this will automatically be collected as part of our data management processes (along with all other information you enter).

If you are visiting our website from a computer linked to a business, we will see and record which business that is. If you are visiting from a personal computer, then we will only see and record which Internet Service Provider you are using (e.g. Sky, BT, Virgin). We will not store your 'IP' address (a code unique to your internet connection) and would not be able to identify you automatically. If, however, you provide information that allows us to identify you through our website (or otherwise) it will be stored. This allows us to contact you if, for example, you leave your email address (and confirmation that you wish to be contacted).

How do we use your data?

When you ask a question through our website, it is automatically recorded, together with the answer you receive. This allows us to:

- administer our website and internal operations, including for use in troubleshooting, data analysis, testing, research, statistical and survey purposes;
- provide you with information about any new features or services we might offer you on our website or to solicit your feedback (we will only do this where you specifically leave your contact details);
- monitor what is being requested through our website to ensure that content from our website is presented in the most effective manner for you and for your device and that you get the most helpful response from our system.

In addition, if you have visited our website from a computer linked to a business or other organisation, we may reach out to the most appropriate persons at that organisation (or you if you have left your name) through publicly available social media accounts (that are corporate in nature). We will not refer to the conversation you had with our 'DIGITAL CONCIERGE' ® application. We will just ask if you would be interested to hear how we can help.

Who can see your data?

We share your information with our employees on a "need to know" basis as well as selected third parties including:

- AI developers, in relation to their provision of artificial intelligence technology, which assists us in answering your questions without human input;
- The Colombo Centre of Cognitive Computing (Pvt) Ltd ("CogCom"), a sister company owned by us, which operates out of Sri Lanka and is working alongside us to further develop our DIGITAL CONCIERGE ® application;
- reputable third party vendors who may receive aggregated statistics about our customers, sales, traffic patterns and related website usage information (but none of this information will include any personal information);
- analytics (including Google Analytics) and search engine providers that assist us in the improvement and optimisation of our website.

We may also disclose your information if we are under a duty to disclose or share your information in order to comply with any legal or contractual obligation, or to protect our rights, property or safety or those of our suppliers, customers, contributors or the public at large.

Just so you know, in the event that we sell or buy any business or assets, we may transfer your information to the prospective seller or buyer, but will ensure they continue to hold your information on the same terms as we have.

Where do we store your data?

All information you provide to us is stored on our secure, encrypted servers. However, the transmission of information via the internet cannot be completely secure. Although we will do our best to protect your information, we cannot guarantee the security of your transmission to our website so any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

Transferring your information outside of Europe

Some of our partners, suppliers, contractors and affiliates, including CogCom, operate outside the European Economic Area (“**EEA**”) and are potentially subject to different data protection laws than the UK. We have legitimate reasons to transfer, process and/or store your information outside of the EEA when it is necessary for the delivery of our service to you, but if you have any problems or queries regarding this then please contact us at information@volume.ai.

16 or Under
